

<p>Outcome: Outcome targets for all child outcomes will be met or exceeded</p>	<p>So that: children served by Cluster G have increased opportunities to fully participate in family and peer activities.</p>
<p>Explanation of Data: Quarterly Data</p> <p><u>July 14-Sept 14:</u> A1: 47.0% (below 53% target; no change from July 13-June 14) A2: 45.0% (below 51% target; no change from July 13-June 14) B1: 54.2% (below 58% target, 4% decrease from July 13-June 14) B2: 62.1% (below 70% target; 6% decrease from July 13-June 14) C1: 56.0% (achieved 55% target; 3% increase from July 13-June 14) C2: 69.1% (achieved 63% target; 2% increase from July 13-June 14)</p> <p>We are still below the targets outcomes A1, A2, B1, and B2. Targets for outcomes C1 and C2 have been achieved. Progress was made in outcomes C1 and C2 compared to last quarter. Outcomes B1 and B2 show slippage compared to last quarter. There was no change for outcomes A1 and A2 compared to last quarter.</p> <p>The new process for exit scoring was implemented in September 2014. Current data largely reflect data collected under the previous scoring system.</p>	<p>Strategies(Who is responsible/timeline/evaluation):</p> <p>If we hypothesize that the data lack validity due to the inconsistency in scoring, then we need a consistent process for determining exit scores:</p> <ul style="list-style-type: none"> • The new process for determining exit scores was implemented on 9/1/14 • Compliance with completion of the exit scores has been excellent across the cluster • The AT manager follows up with agencies if the exit scores appear to be significantly different from the most recent AEPS scores, and/or if the scores do not appear to be accurate. There have been very few issues since the new process was implemented. • Most agencies encouraged or required providers to watch the Child Outcomes Skills Inventory training webinar presented by IIDC and UTS in August 2014. <p>Evaluation</p> <ul style="list-style-type: none"> • Cluster staff and stakeholders (agency leaders) will continue to review data quarterly to assess progress and determine additional strategies as needed. We won't have data reflecting the new scoring process until the Oct-Dec 2014 data are available.
